

CNYR SCCA March 2026 Membership Meeting Minutes

The March 2026 meeting of the Central New York Region of the SCCA was held on Wednesday, March 11, 2026.

The meeting was held in the Wegman's food court at John Glenn Blvd. due to the Liverpool Public Library closing early.

RE Mangicaro called the meeting to order at 7:12 pm. There were 11 attendees.

RE Report:

RE Mangicaro welcomed the attendees to his first meeting as RE.

RE Mangicaro spoke a few words in remembrance of long-time member Rex Franklin.

He then noted the turn out and food were both very good at the awards banquet held at Bella Domini.

RE Mangicaro reported he completed his 2026 annual safety waiver online at SCCA.com and recommended everyone do the same to simplify event registration.

For the future RallyX events, Vince indicated he really needs assistance prepping the courses, moving trailers back and forth between sites (Hastings and Canton) and inventorying the trailer contents. The next event is in June.

Ex-RE Donofrio updated the '26 Region Officers and Chairs on the SCCA website. Permission to purchase sealing materials to repair the Solo trailer was also agreed upon.

New Business:
